



Note:

*A relaxation of 50% shall be provided to the candidate belonging to SC/ST/Physically Disabled (having more than 40% disability) Category.

1. The course work fee for Ph.D course shall be paid by a student once at the time of admission. However, if a student is not able to qualify the Ph.D coursework, he/she shall be required to re-register in the respective paper in which he/she has not been able to qualify, with a fee of Rs.1500/-per paper along with an examination fee of Rs1000/-.
2. Fee once paid to the University shall not be refunded except the security money, which shall be refunded to the student maximum with one year from the date of award of the degree or cancellation of admission on any ground, subject to the adjustment of any dues payable by him/her.
3. The fee may be revised as per need/directive, from the state government.
4. Fee shall be paid only through the online mode.
