समझौता ज्ञापन के अनुसार उच्च शिक्षा विभाग के अन्तर्गत कार्यरत स्थायी कार्मिकों / शिक्षकों को, PNB salary saving scheme (PSSS) के अंतर्गत वर्ग ए के अंतर्गत Personal Accident Insurance Cover एवं Permanent Disability Cover ₹1.5 करोड़ का, Air Accident Cover ₹3 करोड़ तथा तथा कार्मिकों के बच्चों की उच्च शिक्षा एवं पुत्रियों के विवाह के लिए Add-On Cover प्रदान किया गया है। वर्ग बी के अंतर्गत Personal Accident Insurance Cover एवं Permanent Disability Cover ₹1.2 करोड़ का, Air Accident Cover ₹2.4 करोड़ तथा कार्मिकों के बच्चों की उच्च शिक्षा एवं पुत्रियों के विवाह के लिए Add-On Cover प्रदान किया गया है। और वर्ग सी के अन्तर्गत Personal Accident Insurance Cover एवं Permanent Disability Cover ₹1.0 करोड़ का, Air Accident Cover ₹2 करोड़ तथा तथा कार्मिकों के बच्चों की उच्च शिक्षा एवं पुत्रियों के विवाह के लिए Add-On Cover प्रदान किया गया है इसके साथ ही उन्हें ₹0 5 लाख से 12 लाख का Group Term Life Insurance Cover किया जाएगा। स्थायी कार्मिकों/शिक्षकों को पंजाब नेशनल बैंक के PNB salary saving scheme (PSSS) के अन्तर्गत प्रदान किये जाने वाले लाभ का विस्तृत विवरण, उनके लिए किये गये समझौता ज्ञापन के संलग्नक संख्या-1 में उल्लिखित है।

विभागीय संविदा/सेवाप्रदाता के माध्यम से नियुक्त कार्मिकों को पंजाब नेशनल बैंक के PNB salary saving scheme (PSSS) के अन्तर्गत निओ, एक्सेल, ओटिमा और इम्पेरियल के अन्तर्गत ₹30 लाख से ₹125 लाख तक का Personal Accident Insurance Cover, स्थायी विकलांगता की दशा में ₹30 लाख से ₹125 लाख, आंशिक विकलांगता की दशा में ₹15 लाख से ₹62.5 लाख तक का Insurance Cover, Air Accident की दशा में ₹60 लाख से ₹250 लाख तक का Insurance Cover तथा कार्मिक के बच्चों की शिक्षा तथा पुत्रियों के विवाह के लिए Add-On Cover प्रदान किया गया है। विभागीय संविदा के आधार पर नियुक्त कार्मिकों को पंजाब नेशनल बैंक के PNB salary saving scheme (PSSS) के अन्तर्गत प्रदान किये जाने वाले लाभ का विस्तृत विवरण, उनके लिए किये गये समझौता ज्ञापन के संलग्नक संख्या-11 में उल्लिखित है।

4. सामान्य निर्देश

I. जिन स्थायी कार्मिकों/शिक्षकों का खाता पंजाब नेशनल बैंक में है, उन्हें अपना खाता स्टेट गर्वन्मेंट पीएनबी सैलरी पैकेज में बदलना होगा, जिसके लिए सम्बंधित कार्मिक द्वारा समझौता ज्ञापन के अनुसार निःशुल्क आवेदन अपनी संबन्धित शाखा में करना होगा। पीएनबी सैलरी पैकेज के अंतर्गत आने वाले सभी खातों (नए और पुराने) ज़ीरो बैलेंस बचत खाता के अंतर्गत मान्य होगा।

II. जिन स्थायी कार्मिकों/शिक्षकों का खाता पंजाब नेशनल बैंक में नहीं है, उन्हें समझौता ज्ञापन के अन्तर्गत लाभ प्राप्त करने हेतु स्टेट गर्वन्मेंट पीएनबी सैलरी पैकेज के अन्तर्गत सैलरी खाता खोलना होगा। इस हेतु

पीएनबी द्वारा स्थानीय व जिला स्तर पर संबन्धित शिक्षण संस्थानों में निःशुल्क पीएनबी सैलरी पैकेज खाता खोलने हेतु कंप भी आयोजित किया जाएगा। पीएनबी उच्च शिक्षा विभाग की वेबसाइट पर एक ऑनलाइन लिंक उपलब्ध कराने की प्रक्रिया में भी है जहां से संबन्धित स्थायी कार्मिकों/शिक्षक अपना खाता पंजाब नेशनल बैंक में पहले से हैं वे स्वतः ऑनलाइन के माध्यम से पीएनबी सैलरी पैकेज में बदल सकते हैं तथा जिनका खाता पंजाब नेशनल बैंक में नहीं है उन्हें समझौता ज्ञापन के अन्तर्गत लाभ प्राप्त करने हेतु स्टेट गर्वन्मेंट पीएनबी सैलरी पैकेज के अन्तर्गत सैलरी खाता भी स्वतः ऑनलाइन के माध्यम से भी खोल सकते हैं।

III. विभागीय संविदा तथा सेवाप्रदाता के माध्यम से लिए गये कार्मिकों पर भी उक्त दोनों प्रतिबन्ध लागू होंगे, परन्तु उनका खाता पीएनबी सैलरी पैकेज के अन्तर्गत बदलना होगा अथवा खोलना होगा। इसके लिए समझौता ज्ञापन में संलग्न प्रारूप पर सम्बन्धित कार्मिक को आवेदन करना होगा।

IV. सेवाप्रदाता के माध्यम से लिये जाने वाले कार्मिकों को एम०ओ०यू० का लाभ प्रदान करने हेतु एम०ओ०यू० के संलग्नक-II पर सेवाप्रदाता से विवरण विभाग द्वारा प्राप्त किया जायेगा और बैंक को उपलब्ध कराया जायेगा।

VI. समझौता ज्ञापन का क्रियान्वयन सुचारू रूप से और प्रभावी ढंग से हो, इसके लिए आवश्यक है कि उच्च शिक्षा विभाग के अधिकारियों और पंजाब नेशनल बैंक के अधिकारियों के बीच समन्वय हो। क्षेत्रीय उच्च शिक्षा अधिकारी, वित्त नियंत्रक तथा कुलसचिव, समस्त राज्य विश्वविद्यालय एवं प्राचार्य (अशासकीय सहायता प्राप्त महाविद्यालय/स्वावलम्बित मान्यता प्राप्त महाविद्यालय) द्वारा पंजाब नेशनल बैंक के अधिकारियों को आवश्यक सहयोग प्रदान किया जायेगा। बैंक द्वारा कार्मिकों का डाटा मांगे जाने पर उन्हें उपलब्ध कराया जायेगा। क्षेत्रीय उच्च शिक्षा अधिकारी द्वारा पाक्षिक रूप से समझौता ज्ञापन के क्रियान्वयन की समीक्षा की जायेगी तथा प्रगति रिपोर्ट से निदेशक, उच्च शिक्षा, उ०प्र०, प्रयागराज को अवगत कराया जायेगा। निदेशक, उच्च शिक्षा द्वारा प्रतिमाह अपने स्तर से इसकी समीक्षा की जायेगी।

VII. जिलाधिकारी द्वारा त्रै-मासिक तथा मासिक आधार पर होने वाली जिला परियोजना समिति की बैठक में समझौता ज्ञापन के क्रियान्वयन को एजेण्डा बिन्दु के रूप में सम्मिलित किया जायेगा और इसके प्रगति की समीक्षा की जायेगी।

VIII. पंजाब नेशनल बैंक द्वारा अपनी बैंक शाखाओं से नजदीकी उच्च शिक्षण संस्थानों (महाविद्यालयों/विश्वविद्यालयों) की मैपिंग की जायेगी और कैम्प लगाकर खातों को पीएनबी सैलरी पैकेज में परिवर्तित करने और खाता खोलने की कार्यवाही निःशुल्क की जायेगी। विभागीय अधिकारियों द्वारा इसमें आवश्यक सहयोग प्रदान किया जायेगा, परन्तु यह ध्यान रखना आवश्यक है कि इससे पठन-पाठन का कार्य किसी भी तरह से प्रभावित न हो।

IX. जिन स्थायी कार्मिकों/ शिक्षकों को भुगतान डी०डी०ओ० पोर्टल और कोषागार के माध्यम से किया जाता है, उन कार्मिकों का वतन खाता यदि किसी अन्य बैंक में है, तो समझौता ज्ञापन के अन्तर्गत पंजाब नेशनल बैंक में State Government PNB salary saving scheme (PSSS) के अन्तर्गत वतन खाता खोलने की दशा में डी०डी०ओ० द्वारा खाते का अपडेशन डी०डी०ओ० पोर्टल पर नियमानुसार इस प्रकार किया जायेगा, जिससे उनका वतन बाधित न हो।

X. क्षेत्रीय उच्च शिक्षा अधिकारी द्वारा समझौता ज्ञापन के अनुसार Group Life Insurance Cover Personal Accident Insurance (Death)/Total Permanent Disability/Permanent Partial Disablement Cover/Air Accident Insurance (Death) हेतु बैंक द्वारा सम्बन्धित कार्मिकों का डाटा मांगे जाने पर बैंक को उपलब्ध कराया जायेगा और इसमें आवश्यक सहयोग प्रदान किया जायेगा।

XI. बैंक द्वारा कैम्प लगाकर समझौता ज्ञापन का व्यापक प्रचार-प्रसार किया जायेगा तथा पैम्फलेट इत्यादि का वितरण किया जायेगा प्रत्येक प्रकार के Insurance Cover के अन्तर्गत Claim की प्रक्रिया के सम्बंध में कार्मिकों को अवगत कराया जायेगा। विभागीय अधिकारियों द्वारा Claim की प्रक्रिया में कार्मिकों में आवश्यक सहयोग प्रदान किया जायेगा।

XII. पंजाब नेशनल बैंक के मामले में किसी भी शिकायत के सम्बंध में, पहला सम्पर्क बिन्दु पंजाब नेशनल बैंक की सम्बंधित शाखा के शाखा प्रबन्धक होंगे। यदि शिकायत का समाधान नहीं होता है, तो पंजाब नेशनल बैंक के मण्डल कार्यालयों (COs) के नोडल अधिकारियों से सम्पर्क किया जा सकता है। तत्पश्चात अंचल कार्यालयों के नोडल अधिकारियों से सम्पर्क किया जा सकता है।

उपरोक्तानुसार उक्त निर्देशों का कड़ाई से अनुपालन सुनिश्चित किया जाये।

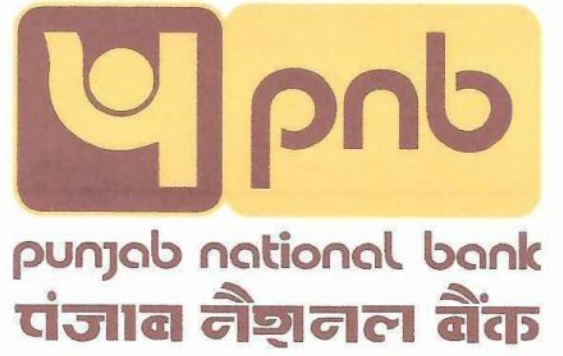

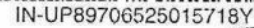
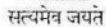

PUNJAB NATIONAL BANK, a body corporate constituted under the Banking Companies (Acquisition and Transfer of Undertakings) Act, 1970 having its Corporate Office at Plot No.4, Sector 10, Dwarka, New Delhi, and Zonal Office at Gomti Nagar, Vibhuti Khand Lucknow-226010, represented by Sh. Pankaj Anand, Zonal Manager, Lucknow, hereinafter referred to "Bank", (which expression shall, unless repugnant to the context or meaning thereof, include its successors and permitted assigns)

In this MOU, the "Bank" and "Department of Higher Education, Government of Uttar Pradesh" shall be individually referred to as "party" and collectively as "parties".

Whereas:

1. Bank is Banking Company within the meaning of the Banking Regulations Act, 1949 inter alia, engaged in the business of providing banking services to its customer in India and abroad.
2. The Bank has offered to provide banking services as detailed in the Memorandum of Understanding to the employees of Department of Higher Education, Government of Uttar Pradesh under "PNB Salary Savings Account Scheme"
3. The Bank offers a specialized salary account product named PNB Salary Savings Account Scheme, which includes various value-added benefits. The value-added benefits are Annexed to this MOU as **Annexure-I for Permanent and Annexure-II for Contractual/Outsourced employees** (employees with residual contract period of one year and above) and same is an integral part of this MoU and is valid only for the Employees of Department of Higher Education, Uttar Pradesh, Lucknow.

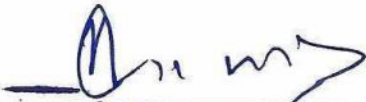
"Purpose and Scope"

This MoU outlines the mutual understanding between the Bank and the Department of Higher Education, Government of Uttar Pradesh for opening salary accounts for their staff under the PNB Salary Savings Account Scheme.

"Roles and Responsibilities"

1. The bank will open the salary accounts for all the eligible employees of Department of Higher Education, Government of Uttar Pradesh under the PNB Salary Savings Account Scheme including the following value-added benefits:
 - No Minimum Balance Requirements
 - Customized Account Number
 - Personal Accidental Insurance
 - Term Insurance

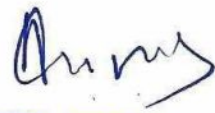

2. The employer shall endeavor, on a best-effort basis, to periodically inform the bank regarding employee superannuation, resignation, or termination. However, the ultimate responsibility to notify the bank of any change in employment status or salary eligibility rests with the individual account holder (employee). The Department assumes no liability for any delays or omissions in providing such information.
3. For insurance benefits, the Bank's role is that of a facilitator and decision of admission into the insurance scheme and the liabilities of the claim settlement would rest with Insurance company. All admissible claims will be payable by the insurance company.
4. In context of role & responsibilities, the banks role will be limited only up to paying the insurance premium. Claim settlement related issues associated with complimentary insurances to be directly taken up by the employer/employee concerned, with the insurance company. All correspondence in submitting, processing and settlement of the claim shall be between Insurance company and claimant directly. Bank shall have no liability whatsoever in this regard.
5. The employee must mandatorily ensure to mention the details of nominee/s for account opening, Personal Accidental Insurance (PAI), Term Life Insurance (TLI) & Hospicash in the account opening form and declaration form.
6. If the salary of any employee gets increased or decreased to such an extent that the employee becomes eligible to move from one variant to another variant of PNB Salary Savings Account Scheme, then the employee must inform the bank so that the conversion of the account can be done accordingly. However, if escalation happens, once insurance premium paid by the Bank for one employee, the benefits of enhanced escalation will be provided on the maturity of present policy, i.e. after one year of policy issuance.
7. In case the employee does not fulfil the criteria after availing the value added benefits, the account will be treated as normal Savings Bank Account and the charge for all the value added features will be recovered from the employee.
8. The organization shall not disclose the contents of this MoU to any other Bank or Financial Institution without the prior written consent of the other party of this MoU.

"Period of MoU"

1. This MoU shall remain valid for a period of Five (5) years from the Effective Date i.e. from 26.07.2026 onward, unless terminated earlier in accordance with this MoU. This MOU will be extended to further period 5 (Five) years on the option of Department of Higher Education, Government of Uttar Pradesh by way of mutual written consent of both the Parties and subject to the Bank's prevailing policies.
2. In case either of the party does not come forward for any review or revision for extending it after five years (5), it shall be at the sole discretion of the Bank to continue, modify or discontinue the value-added benefits under the Scheme, as per the Bank's prevailing policies/guidelines.
3. This MoU may be terminated: (a) by mutual written agreement of both the parties at any time; (b) by either party upon written notice to the other party 1 (One) month advance notice; or (c) immediately by either party in the event of a material breach of this MoU by the other party, provided such breach remains uncured for 1 (one) month from the date of notice.
4. In the event of termination of the MoU between Department of Higher Education, Government of Uttar Pradesh and the Bank, employees must be duly informed by the employer to stop any possibility of future disputes by the employees.

"Amendments"

This MoU may be amended or modified at any time by mutual written agreement of the Parties. No provision of this MoU shall be amend, waived, or supplemented except by a written instrument executed and signed by authorized representatives of both the Parties. Any such amendment shall form an integral part of this MoU and shall be binding upon the parties.

"Notices"

Any notices, requests, demands or other communications to be given under this MoU shall be in writing and shall be deemed to have been duly delivered by hand or by courier or registered post to a Party at its address specified under this clause, or such other address as either Party may from time to time notify in writing to the other, or by facsimile or email to the respective Parties hereto at the email addresses and facsimile numbers set forth.

No confidential information shall be disclosed to any third party without the prior written consent of the other Party, except as required by applicable law or regulatory authorities.

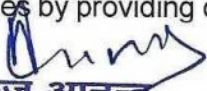
"Dispute Resolution": In case of unavoidable circumstances beyond the control of bank, if any delay/failure occurs the same shall be amicably resolved between the parties hereto. In case such resolution becomes impossible, the matter shall be referred to arbitration to a sole arbitrator to be appointed mutual consent of both the parties in terms of Arbitration and Conciliation Act, 1996. The decision of the arbitrator shall be final & binding on the parties. Arbitration may be considered as an additional remedy, and it does not preclude the Parties to seek redressal /other legal recourse. "Governing Law"

This MoU shall be governed by and construed in accordance with the laws of India, including the Indian Contract Act, 1872 and other applicable statutes.

"Force Majeure"

1. If at any time during the continuance of this MOU, the performance in whole or in part by any of the parties to any of the objectives obligations under this MOU is prevented or delayed by reason of governmental decision, war, hostilities, act of a public enemy, act of god, civil commotion, sabotage, fire, flood, epidemics, quarantine restrictions, disturbance in supplies from normally reliable sources including earthquake, explosion but not limited to electricity, water, fuel and the like, strike, lockout or other event beyond the reasonable control of the party concerned (hereinafter referred to as "Force Majeure"), then notice of such event shall be given by the affected party to the other parties within 15 days from the date of occurrence thereof.
2. In the event of any parties not being able to by reason of force majeure, meet any of its obligations under this MOU, such obligations shall be suspended for as long as the inability continues or any date mutually agreed between the parties. This MOU may be terminated by any of the parties by providing one (1)

month written notice, if the inability to undertake activities under this MOU continues even after expiry of the notice.

3. It is expressly agreed by the Parties herein that the relationship between them under this MOU is on Principal-to-Principal basis.

“Term Insurance and Personal Accidental Insurance”

1. The employees are eligible for Term Insurance and Personal Accidental Insurance coverage at free of cost. The cost towards the insurance will be borne by the bank. Claim settlement related issues associated with complimentary insurances to be directly taken up by the employer/ employee concerned, with the insurance company.
2. The Bank's role to that of an administrator/ facilitator and decision of admission into the insurance scheme and the liabilities of the claim settlement would rest with Insurance company. All admissible claims will be payable by the insurance company. Bank shall have no liability whatsoever in respect thereof. All correspondence in submitting, processing and settlement of the claim shall be between Insurance company and claimant directly. Bank shall have no liability whatsoever in this regard.
3. It is the responsibility of the employee to inform about his/her superannuation/ resignation/ termination of service/ suspension so as to enable to remove the employee from the list of beneficiaries under insurance schemes.
4. Subject to the eligibility criteria applicable for the product/ variants of the account, benefits are provided for a period of one year only (like insurance coverage for one year). Further continuation of the benefits (in full or in part) is subject to Bank's discretion / guidelines issued by the Competent Authority from time to time.

“Disability Arisen out of Personal Accident”

1. If an employee succumbed to injuries due to Personal Accident and disability arisen out of that, the employee based on the Permanent Total Disability (PTD) or Permanent Partial Disability (PPD) can avail insurance benefits as per guidelines, from the insurance company without any charges.
2. The percentage of PTD/ PPD will be calculated as per the prevailing IRDAI guidelines.
3. The assessment of the percentage of disability will be assessed by the panel of doctors of the Insurance Company. The claim amount shall be settled by the insurance company and shall be credited to the beneficiary's account based on the disability percentage as per IRDAI guidelines.

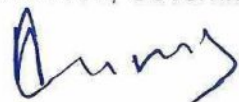
"Miscellaneous"

1. As regards "KNOW YOUR CUSTOMER norms" as per RBI guidelines, PAN/ Form 60 and one officially valid document (OVDs) to be provided for opening of Bank accounts. These instructions will be governed by directions issued by RBI/ Bank from time to time.
2. Benefits offered in Debit Cards are subject to change from time to time as per guidelines issued by respective service provider (NPCI, RBI etc.)
3. **Conversion in Case of Non-compliance:** If no salary is credited for six consecutive months and the prescribed 6-month Average Balance is not maintained, the account shall be reclassified as a PNB Unnati Savings Account. Upon such reclassification, the benefits and features of the Salary Account Scheme shall be withdrawn. Furthermore, applicable charges for any Debit Card facility availed shall be levied with effect from the date of reclassification.
4. If more than one salary accounts are opened for any customer, insurance benefits will only be provided for only that account in which salary is getting credited.
5. The banks role will be limited only up to paying the insurance premium. Claim settlement related issues associated with complimentary insurances to be directly taken up by the employer/employee concerned, with the insurance company.
6. Insurance claim should be intimated within 90 days from the date of accident/ death.
7. In case of transfer of any employee, that employee will be free to transfer his account from one branch of the Bank to another.

"Definitions"

1. **"Family"** includes the employees and their eligible family members as detailed below:
 - i. Legal spouse of the employee
 - ii. Children of the employee — till they get employed or married or attain the age of 25 years whichever is earlier.
 - iii. "Employee" means employee of Department of Higher Education, Government of Uttar Pradesh.
 - iv. "Employer" means Department of Higher Education, Government of Uttar Pradesh.
 - v. "Organization" means Department of Higher Education, Government of Uttar Pradesh.

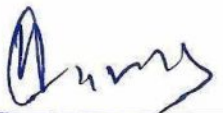

2. **"Accident"** An accident means sudden, unforeseen, and involuntary event caused by external, visible, and violent means.
3. **"Beneficiary"** means Employees and their eligible family members of Department of Higher Education, Government of Uttar Pradesh.
4. **"Term Insurance"** means a life insurance policy that pays a death benefit only if the employee dies during the policy term (other than suicide).
5. **"Accidental Insurance"** means a type of insurance that provides financial coverage for permanent partial disability, permanent total disability and death resulting from unforeseen accidents.
6. **"Premium"** means the amount payable by the Bank to the Insurance Company for maintaining the insurance policy in force, subject to the terms and conditions of the applicable insurance policy".
7. **"Higher Education Cover (18 to 25 years)"** — In the event of death of insured person due to accident and if a claim is accepted as a valid claim, then this benefit will be extended to one child of the insured person, pursuing full time course in Graduation or higher studies in a recognized college in India. An amount equivalent to 10% of the base sum *insured* will be payable.
8. **"Permanent Total Disability (PTD)"** — In the event of injury occurring to the insured person solely and directly from the accident caused by external, violent and visible means and which result in total irrecoverable loss as total permanent disablement (as defined by IRDAI) within 12 calendar months of its occurrence, the claim will be settled by the insurance company as per IRDAI Guidelines.
9. **"Permanent Partial Disability (PPD)"** - In the event of injury occurring to the insured person solely and directly from the accident caused by external, violent and visible means and which result in partial irrecoverable loss of use or the actual loss by physical separation where a part of the body becomes permanently disabled (as per IRDAI guidelines) within 12 calendar months of its occurrence, the claim will be settled by the insurance company as per IRDAI guidelines.
10. **"Air Accidental Insurance"** — In the event of death due to air accident occurring while undertaking journey by Airlines subject to booking of tickets through any type of mode of payment linked with the salary account of our bank.

"Other Terms and Conditions"

1. It is explicitly agreed and understood that the Department of Higher Education, Government of Uttar Pradesh, acts solely as a facilitator to enable the opening of salary accounts for its employees. The Government, its officers, and its departments shall bear absolutely no financial, legal, or administrative liability whatsoever regarding the operation of these accounts, the delivery of value-added benefits, insurance claim settlements, or any service deficiencies by the Bank or its affiliated Insurance Companies. All financial obligations, disputes, and claims arising from the 'PNB Salary Savings Account Scheme' shall remain strictly between the Bank, the respective Insurance Provider, and the individual Employee.
2. Notwithstanding anything contained elsewhere in this MoU or any associated

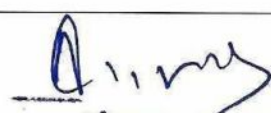
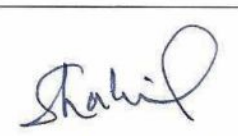
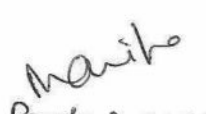

Terms & Conditions:

1. Features related to the scheme will be admissible upon activation of the account under respective scheme. The same features will also be available in case of transfer of account from any scheme to respective scheme.

2. **Banking features of the scheme:** The Banking features under the scheme—such as RTGS, NEFT, IMPS, SMS alerts, Cheque Book, Demand Draft (DD), Passbook, Zero Balance Family Account facility, Sweep-in/Sweep-out facility, concession in Demat account charges, etc.—shall be extended free of charge upon activation of the account through fresh opening or transfer-in under the scheme.

3. **Personal Accidental Insurance Cover, Term Insurance and Hospicash** benefits shall be made available with effect from the date of activation in case of new account opening or from the day immediately succeeding the date of conversion of an existing account into the New Salary Account Scheme.

Term Insurance coverage includes death due to any cause, including natural death, death due to any illness and pre-existing illness. However, compensation will not be payable in the event of death by suicide within the first year of coverage for the specific insured person.

7. **Hospicash** refers to a type of health insurance that provides a fixed daily cash benefit for each day of hospitalization. Under **Hospicash** policy, hospitalization for all types of treatment shall be covered, details of sum assured as given below: -

- o Upto ₹30,000 (₹1,000 X 7 per Day in a single instance) (max for 30 days)
- o Upto ₹60,000 (₹2,000 X 7 per Day in a single instance) (max for 30 days)

8. For PAI, Term Insurance & Hospicash, separate operational guidelines and detailed process will be as per bank guidelines.

9. **Allocation of Lockers:** Locker allotment shall be subject to availability. Priority in allotment shall be accorded to customers registered in the waitlist. The benefit of locker charges waiver for first-year upon locker issuance will be granted only once on first time locker issuance after account opening or account transfer into this scheme. In case the locker is surrendered after availing the

first-year rent waiver benefit, any subsequent allotment of locker shall not be eligible for the first-year rent waiver.

10. Features and benefits associated with Debit Card under new salary scheme will be provided only after availing new Debit Card (under Card type SAN, SAP, SAO, SAI). The insurance coverage extended to the Debit Card holder is an additional benefit and is governed by the guidelines issued by NPCI (National Payments Corporation of India), which are subject to revision from time to time. Insurance cover available under Debit Card shall be settled separately as per extant guidelines.

11. In case the accountholder wishes to avail a Debit Card and/or Credit Card of a different network or opt for a variant other than the complimentary card provided under the Salary Savings Account Scheme, the same may be issued based on eligibility and subject to applicable terms and conditions.

However, benefits related to such cards shall be governed by the respective card-specific guidelines issued from time to time and not by the Salary Savings Account Scheme. Further, in case of any Debit Card variant other than the complimentary one, applicable issuance charges and Annual Maintenance Charges (AMC) shall be levied as per the prevailing schedule of charges.

12. Family members that can be linked are Spouse & 2 Children: Under the Family Banking benefit, the Salary Account holder may link the Savings Accounts of eligible family members—restricted to **spouse and up to two children**—through CBS menu option 'LNPMC'. 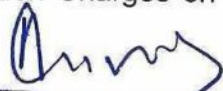

- An interest rate concession of 0.05% for Housing Loan & 0.10% for Vehicle Loan shall be applicable for Customer under EXCEL, OPTIMA, and IMPERIAL Salary Account variants. **This benefit is not applicable for the NEO variant.**

18. Continuation of Salary Account Benefits:

The benefits and features of the New Salary Account Scheme shall be available **only in accounts where salary is credited on a regular basis**.
